Description of Material Information or Fact	<p>Kindly be informed that we have received the official copy of Supreme Court of Republic of Indonesia Verdict on lawsuit number 1515K/Pdt/2017 juncto Number 549/Pdt/2015/PT.DKI juncto Number 322/Pdt.G/2014/PN.Jkt.Sel on 2nd May 2018.</p> <p>This verdict is a decision upon the Cassation to the civil lawsuit Verdict of the High Court Number 549/Pdt/2015/PT.DKI juncto District Court Verdict Number 322/Pdt.G/2014/PN.Jkt.Sel that was filed by Dr. Mintarsih A. Latief ("Appeal Petitioner I"), Lani Wibowo and Elliana Wibowo ("the Appeal Petitioners II") against PT Blue Bird Taxi ("BBT") as Appellee in Cassation I, Dr. Purnomo Prawiro Mangkusudjono as Appellee in Cassation II, PT Blue Bird, Tbk as Co-appellee in Cassation II, along with other parties as the Co-Appellee in Cassation with decisions are as follows:</p> <ol style="list-style-type: none">1. To reject the Cassation petition from the Appeal Petitioner I : Dr. MINTARSIH A LATIEF and the Appeal Petitioners II: 1. LANI WIBOWO, 2. ELLIANA WIBOWO;2. To punish the Appeal Petitioners II (formerly the Plaintiffs/ the Appellants I) to pay court costs in the Cassation level in amount of Rp 500.000,- (five hundred thousand Indonesian Rupiah). <p>Previously, DKI Jakarta High Court with its Verdict number 549/Pdt/2015/PT.DKI dated 16th December 2015 has decided substantially: to strengthen the South Jakarta District Court Verdict Number 322/Pdt.G/2014/PN.Jkt.Sel dated 1st April 2015 which decision is substantially rejected all the lawsuits from the Plaintiffs (Lani Wibowo and Elliana Wibowo) in certain petitums and decided that the Plaintiffs' lawsuits on the rest of the petitums cannot be accepted.</p>
